**1** Briefly describe the organization's mission or most significant activities:  
HIGH SCHOOL YOUTH EDUCATION PROGRAMMING AND SERVICES, ESPECIALLY RELATED TO SMALL URBAN HIGH SCHOOL PROGRAMS AND CONNECTIONS FOR STUDENTS AND THEIR FAMILIES. WE PUT PARTICULAR EMPHASIS ON THE SAFETY BENEFITS THAT SMALL HIGH SCHOOLS PROVIDE TO THEIR STUDENTS AND FAMILIES (SEE THE KAISER REPORT ON SCHOOL SHOOTINGS AND SCHOOL SAFETY). WE INCREASED THE RESEARCH AND SUPPORT OF THE SMALL HIGH SCHOOL CONCEPT AS IT RELATES TO AND PROVIDES FOR SCHOOL SAFETY, ESPECIALLY RELATING TO DISTRIBUTION OF THE DAVID A KAISER RESEARCH REPORTS. IT WAS IN 2017 THAT THE MONTANA LEGISLATURE FINALLY PROVIDED THE INDEPENDENT ELEMENTARY SCHOOL DISTRICTS AND THEIR PEOPLE THE OPPORTUNITY TO EXPAND TO K12 PROGRAMS (WITH THEIR OWN HIGH SCHOOLS). IN NOVEMBER OF 2017 TWO OF THOSE COMMUNITIES VOTED TO DO THEIR EXPANSION (AND IN 2018 THEY APPROVED BONDS FOR OVER \$80 MILLION TO BUILD HIGH SCHOOL FACILITIES AT BOTH EAST HELENA AND LOCKWOOD).
