In addition, section 3.2 also stipulates that there be 4 ex-officio members with voting power (the president and CEO, two representatives from the Committees of Resident Companies, and the chair or a co-chair of the Harris Theater Associate Board). Section 4.1 outlines the structure of officers to include a chair, one or more vice chairs, a president and chief executive officer, a secretary, and a treasurer. Section 4.1 makes special note that any two or more officers may be held by the same person, except the officer of president and secretary.</p>
