Dr. Nasatir began receiving payments under this agreement in 2009. During 2012, the Jewish Federation entered into a second agreement with Steven Nasatir which provides for annual payments of \$5,000 beginning April 1, 2015 and lasting throughout his lifetime. The \$50,000 and \$5,000 annual payment amounts are to be adjusted annually in accordance with the CPI index. In 2017, Steven Nasatir received payments totaling \$80,412 from the two supplemental non-qualified retirement plans. In August 2017, the Jewish Federation of Metropolitan Chicago entered into a third agreement with Dr. Nasatir which provides for annual payments of \$21,000 per year, beginning in January 2018, for the longer of 1) his lifetime or 2) 10 years (through December 2027). In addition, this agreement added a 10 year guaranteed payment stream to Dr. Nasatir's first two arrangements which means these payments will continue for the longer of 1) his lifetime or 2) 10 years (through December 2028).</p>
