





The total population for all five counties, including Detroit, is a little over 4 million. The percentage of persons living below poverty ranges from 5.2% to 34.5%. Research has established that factors such as economic status, employment, housing, education level, and built environment can all be powerful social determinants of health. Additionally, helping to create higher capacity within the community to address a broad range of quality of life issues also impacts health. Ascension Southeast Michigan Hospital administrators and staff have provided leadership and participated on collaborative initiatives with Greater Detroit Area Health Council, Wayne County Health Department, The City of Detroit Department of Health and Wellness Promotion, Michigan Crime Victim Services Commission, The Michigan Department of Health and Human Services, Michigan Primary Care Association, area Federally Qualified Health Centers, and other community organizations to identify community needs and address community problems. Ascension Southeast Michigan Hospitals have a demonstrated history and strong foundation built upon its Mission, Vision, and Values. It is this spirit that leads the institution and drives health care services. Often patients, family members, friends, and the like are pleased with our position of care - to heal the body, mind, and spirit, have experienced it first-hand, and wish to show their appreciation by making a gift to support the care of others that are vulnerable. The spiritual essence that's woven into the fabric of our daily operations allows members of the community to comfortably and directly impact the lives of others through philanthropy. We work to create an ethical legacy for emphasizing the critical value of community and encourage the compassionate generosity of others to make gifts that enhance the exemplary care that we have been recognized for in the health care system. The hospitals promote the health of the community in a variety of ways, either directly providing services or in partnership and /or collaboration with other organizations serving the community. We directly serve the community through 25 school-based health centers in the Southeast Michigan area. The schools are selected based on a minimum of 70% of students receiving free or reduced lunch, indicating a lower family income. Services to these students include physical and psychosocial support. We partner with a mobile dental service to provide onsite dental services to improve access to needed care. The school team consists of a nurse or nurse practitioner, a medical assistant, and a mental health therapist. There are special programs for students identified with asthma including an annual free asthma camp for students. Noting that heart disease is a leading cause of death in the entire hospital service area, the health system has an annual heart health fair at selected hospitals to provide onsite health screening and assessment by a team. Grief support and support for victims of crime are provided to children and youth through a special initiative at our Detroit based hospital. Partnerships with over 80 churches are a vehicle that provides health education and screening to the general community through the faith community nursing initiative. There are four community wellness centers offering enhanced fitness and other physical and educational sessions offered to the general population of three counties in the service area. In FY 2020, the four community wellness centers had over 17,000 encounters. Also, monthly programming and health education classes are offered at seven parks and recreation centers and senior centers in our service areas. Ascension has instituted a nationally recognized initiative to help eradicate human trafficking. Our team of specifically trained master's level social workers are subject matter experts in the human trafficking. As content experts, they provide training to Ascension emergency department staff, nurses on the inpatient units, case managers and social workers on how to identify possible victims, initiate human trafficking protocols and protect themselves from retaliation. We partner with other agencies serving the general community to promote health, including Gleaners food bank and Forgotten Harvest to address food insecurity. We partner with the local federally qualified health centers via participation in the Southeastern Michigan FQHC council and membership in the Michigan primary care association. We partner with the local chapter of the Kidney Foundation to provide diabetes prevention and diabetes management education in several community locations. Other partnerships/collaboration include Detroit Wayne Mental Health Authority, the local sane (sexual assault network), several domestic violence shelters, Southeastern Michigan infant mortality reduction task force, Greater Detroit Area Health Council, Detroit, Wayne, Oakland, St. Clair and Macomb health departments,</p>

The health system publishes and distributes over 80,000 bimonthly educational newsletters called "CareLink" targeting adults 55 and older, which includes informative articles as well as a schedule of educational classes on topics such as CPR, diabetes, preventing falls, heart health, and other health topics. All classes are open to the public, and the majority are free of charge. Further, the health system has two mobile units that provide mammography services to uninsured and underserved women and a heart and vascular mobile unit that provides a basic heart profile at churches, community centers, corporations, and other locations. The structure of the health system calls for a statewide governing board that includes members from the local hospital service area. Further, we have several advisory committees composed of residents and agencies serving the community, such as the parent and separate student advisory groups for the school-based health centers, the local mission committee, the local foundation boards, and other services specific advisory groups. Medical staff by-laws for each hospital guide offering privileges to qualified physicians in the communities surrounding each of the hospitals. Each teaching hospital has a medical education department for the training of residents and fellows. Each site hosts an annual research day. This long standing tradition, which has been in existence for over 80 years at some of our sites, brings clinicians and graduate medical students together to discuss current medical research being conducted at the hospital. This work encompasses everything from retrospective medical chart review to analysis of the latest therapeutics and medical devices. The primary goal is to teach residents and fellow researchers how to research to improve patient care and advance the practice of medicine. Examples of this work include the following; "lack of screening for intimate partner violence in primary care settings"; an effort to reduce 30-day readmission rates in chronic obstructive pulmonary disease"; and "telemedicine" and "tighter blood pressure control" to name a few. Also, the medical staff participates in an annual summer biomedical exposure program for 20 area college students. The program introduces the students to the broad field of medicine. In all, the department supports ongoing research by residents, fellows, and physicians and provides Research and EIB review as well as oversight and guidance to remain in compliance with current rules and regulations.</p>

Paper and online surveys were sent to community members and key stakeholders from June 2018 - December 2018. The public survey was administered at the following: physician offices, community health fairs, community health wellness centers (Southfield, Riverview/Detroit, and Livingston), and the Annual Christmas store located at Ascension Providence Hospital, Southfield campus. The key stakeholders' survey was administered at the following, local public health department leaders, faith-based organization leaders, principals, and superintendents from the schools where our school-based health centers are located. Evidence from the Diabetes Prevention Program demonstrated pre-diabetes risk could be reduced by 5-7% when those at high risk make modest lifestyle changes, explicitly losing 5-7% body weight and being physically active 5 days a week for at least 30 minutes. In FY 2020 (Tax year 2019), 5 DPP cohorts were completed, and 73% of adult participants decreased their weight by 5-7%, which is the recommendation from the CDC for reducing the risk of pre-diabetes. At the end of the program, the students increase their knowledge of healthy eating and physical activity by 98% and increase their healthy diet and exercise by 96%. The implementation strategy for Goal (1): Increase access to mental health programs/services for children, youth, and adults, through the Ascension Southeast Michigan Community health school-based health centers and referrals to Eastwood clinics from the Ascension Southeast Michigan hospitals and physician offices. (2): Decrease youth risk factors for suicide, depression and substance abuse. The implementation strategies for Goal (2): Strategy (1) Implement the Rapid Assessment for Adolescent Preventive Services (RAAPS) as a suicide risk screening and provide mental health education, counseling, and referral for youth in partner schools. Goal (2) Strategy (2): Implement Red Flags mental health education, counseling, and referral for youth in partner schools. The Mental Health/Substance Abuse prevention need is being addressed by increasing access to mental health programs/services for children and adults. For youth in particular, the focus is to screen them for depression and suicide. The Ascension Southeast Michigan School Based Health Centers utilizes the Rapid Assessment for Adolescent Preventive Services (RAAPS) as a risk screening for depression and suicide for students. In turn, based on the results students are counseled or referred externally for mental health treatment. In FY 2020 (Tax year 2019), 815 students were screened, 61 students counseled for depression, 20 students counseled for s</p>

Also, our Eastwood clinics that specialize in mental/behavioral health services converted over 35% of referrals to scheduled appointments. Prioritized Need: Improving Maternal and Infant Health. There is one goal for the need: improving maternal and infant health. Goal: Improve the health and well-being of women and infants. The implementation strategies for the goal are: Strategy (1) Implement the Maternal Infant Health Program (MIHP), which provides evidence-based services to improve awareness, knowledge, and behaviors for preventing maternal mortality and infant mortality for communities, including vulnerable and at-risk populations. Also, we also increased their knowledge on breastfeeding and safe sleep practices. The parenting classes serve at-risk pregnant women and their families in an effort to produce healthy maternal outcomes, as well as reduce the number of infant deaths at birth and during the first year of life. In FY 2020 we increased participation in our parenting classes over 25%. Needs That Will Not Be Prioritized In our FY 2019 CHNA planning, other needs were present from our primary and secondary data. However, after completing the Hanlon method the following are needs we decided we would not prioritize in this CHNA. Access to care was identified as a need by the Hanlon Method prioritization. However, the CHNA steering committee confirmed through the final prioritization assessment that it is a low priority need. Due to MI Medicaid expansion, a large amount of the population in the Southeast Michigan area have health insurance and a primary care provider. Also, it would be challenging to make a measurable impact on health insurance cost. Also, the utilization of a primary care provider, and routine check-ups are behavioral activities that can be encouraged through education from the main three priorities. However, we continue to collaborate with a local Federal Qualified Health Center to support access to specialty and dental care. A sub-category under Access to care is adequate prenatal care that will be addressed under the Improving Maternal/Infant Health priority.</p>
