The countries visited included the Democratic Republic of the Congo (entrepreneurship workshops), Madagascar (community outreach, healthcare provision, and entrepreneurship workshops), South Africa (mercy ministry at multiple orphanages, community outreach, construction projects, and Faith & Work events), India (sex-trafficking victims ministry), Japan (performing arts ministry and Faith & Work workshops), Philippines (post-typhoon rebuilding efforts and church ministry), and Guatemala (healthcare provision, mercy ministry at multiple orphanages, and community outreach)
