Grants are made usually when the grantee has additional sources of external funding beyond the grant from Redeemer City to City. Scholarship recipients of the City Ministry Program must demonstrate financial need, a calling to serve in NYC in ministry and exhibit emerging ministry abilities to serve in NYC. Scholarships are applied directly to each student's class expense.
