CTC launched its initiative to embed training on faith & work into its core training for pastors and leaders in 2018. Under this initiative, CTC is continuing to work to expand the Global Gotham Network into new cities and churches. The Global Gotham Network is a collective of ministries running Gotham Fellowship cohorts in their respective cities. This training operated in 12 cities with 269 fellows participating in the nine-month faith and work intensive.
