Education Programs The PYC Arts & Tech High School, a Contract Alternative Program with Minneapolis Pubic Schools, provides a diploma-based high school education for over 300 students yearly on the PCYC campus in North Minneapolis at Oliver and West Broadway In operation since the early 1970s, the school infuses arts and arts technology into the core curriculum as a strategy to enhance academic performance and teach life-long learning skills In addition to academic coursework, the school provides wrap-around services in the areas of social work support, an on-site adolescent health clinic, career, college and vocational planning and experiences, service learning, and family outreach All activities are guided by PCYCs Strategic Goal to Tackle the Achievement Gap Head-On Key result in school year 2015-16 83% of school year eligible seniors earned their high school diploma and graduated with the Class of 2016

B Youth Development Programs The PCYC Youth Development Program (also called the Out of School Time Program) promotes positive youth development, academic achievement and social emotional learning activities for over 200 elementary children on a year-round basis, in collaboration with the Northside Achievement Zone Key results for OST participants In school year 2015-16 76% of the approximate 120 children made at least 1 years growth in reading (up from 68% in 14-15), 50% made more than one years growth (up from 44%) and 69% tested proficient in math fact for their grade level (up from 63%) In Summer Friends 2016 100% of the children had no summer slide in reading levels for the 9th summer in a row PCYC also offers a summer outdoor park program in the neighborhood, with approximately 80 children and youth participating daily The annual Childrens Christmas Gift Event draws well over 1,200 children and some 300 volunteers to PCYC in December each year, where for a modest price they select gifts to give to their family members All activities are guided by PCYCs Strategic Goal to Increase Opportunities for School and Life Success

C Cultural Arts Centered on the Capri Theater, which is owned and operated by PCYC, the agency is carrying out the Strategic Goal to Bring Up the lights on year-round arts programming that draws thousands of youth and adults to a top-notch North Minneapolis performing venue on West Broadway 2014-15 accomplishments include Legends Jazz Series audience averaged 65% of seating capacity, drawing audiences from the neighborhood as well as from the region, growing number of groups and residents are renting the Capri for their performances and events, successful programs for youth - CAST (Capri after school theater program for teens), Camp Capri (summer arts camp for middle schoolers), and the Capri Apprenticeship Program all offer skill-development and training for over 100 youth in theater and all its aspects The on-going collaboration with the St Paul Chamber Orchestra resulted in packed houses for free chamber music concerts
