Living with two or three housemates is an opportunity to learn teamwork skills and enjoy longterm friendships. General health is monitored by staff who also provide the support needed for medical, dental and psychiatric appointments.

Intermediate Care Facility (ICF): since 1974, the ICF program has offered people the opportunity to share an apartment and enjoy the privacy of their private bedroom. Teaching focuses on increasing and maintaining independent living skills. Recreational resources reflect individuality through creative opportunities with the home and throughout the community. The ICF offers the opportunity to lead an active life after retirement and, for many, also offers the nursing support to remain with Harry Meyering Center till the end of life.
