Knute Nelson, an affiliate of Evangelical Lutheran Church of America, served over 8,200 older adults throughout their care continuum in 2019. This expansive continuum of care includes Care Center, Short-Term Rehab Center, Skilled Memory Care, Assisted Living, Enhanced Assisted Living, Memory Care Assisted Living, Independent Living, Out-Patient Therapy, Wellness, Home Care, Hospice, Telehealth, Management Consulting, Pioneer Grill and Catering. Partnerships extend the breadth and depth of services such as Ethos Home Care and Hospice in Fargo-Moorhead, Alexandria Area YMCA in Alexandria, Franciscan Sisters of Little Falls, Crystal Brook Senior Living in Park Rapids, Pelican Valley Senior Living in Pelican Rapids, Centrex Rehab in Bloomington, and Care Ventures Cooperative in Dassel.
