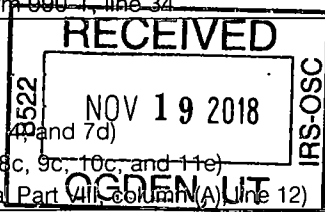

The students are taught regular school subjects including science and mathematics as prescribed by the Board of Secondary Education as well as spiritual teachings based on the philosophy of Bhagavad Geeta. The students are provided midday meals at the school. Geeta Dham is striving to make the project more self-sufficient by growing vegetables in the garden, running a small dairy farm on the Geeta Dham grounds, and using the manure to produce methane cooking gas. The school library has more than 850 books and computer facilities. High performance demonstrated by the students of the school in State level examinations has earned the school much fame that is attracting students in greater numbers.

Grants were made in recognition of school's charitable mission and continued demonstration of superior performance; and in support of improvements to school facilities and teaching infrastructure.

The organization receives periodic reports on the project, including information on how the grant funds were used, progress achieved, etc. Geeta Dham representatives are in regular communication with certain Board members of the organization and share relevant information. Board members have occasionally visited the project site at Geeta Dham during their travel to India and personally viewed the progress. So far the performance has exceeded expectations.
