EDUCATION AND HOUSING STABILITY ARE KEY LEVERS AT THE HEART OF JEREMIAH PROGRAM'S MODEL. THE ORGANIZATION PARTNERS WITH FAMILIES HEADED BY SINGLE MOTHERS WHOSE CONNECTIONS TO THE EDUCATIONAL AND ECONOMIC RESOURCES NEEDED TO BUILD FAMILY WELL-BEING HAVE BECOME FRAYED OVER TIME BY ECONOMIC, RACIAL, AND SOCIAL MARGINALIZATION.
