Hospital Services. In keeping with our mission of healing and comforting the sick, providing hospital medical services is at the heart of what we do. These services are provided in inpatient and outpatient settings, in situations that may be emergent, acute or chronic. Services include a 24 hour emergency unit, intensive and cardiovascular care. We also service a maternity unit and newborn nursery along with other surgical services, cardiac cath lab, cancer care, digestive care, telemetry monitored care, medical care, stroke care and behavioral and hospice care.

Form 990, Part III, Line 4b:

Education. The ongoing education of Mercy staff is critical in the fast changing field of health care and it necessary to meet regulations and certifications. Mercy hosts a number of professional continuing education classes each year, which is attended by it's own staff and staff from other institutions. Mercy provides a setting for students who are considering a career in health care including a class of insight to possible careers and preparation for CNA exam.

Form 990, Part III, Line 4c:

Community Benefit. Mercy's community benefits take many forms, beginning with the traditional charity care of (\$1.0 million) and the unpaid cost of Medicaid (\$6.2 million). Other examples include cash donations to community non-for-profits such as the Free Medical Clinic, leadership time and skills that further the work of the non-for-profits, first aid booth provided at public events including the Johnson Co Fair. These efforts are detailed in Mercy's community health benefit report. As a trusted, longtime member of the community, Mercy plays an important role not only in further community health but the general community good.

Part II, Community Building Activities:	<p>Economic Development: Mercy works with such groups as the Iowa City Area Chamber of Commerce and Iowa City Area Development Group to support the business community, welcome innovators to the area, and develop the workforce. Mercy continues to partner with the 40-bed Mercy Inpatient Rehabilitation Hospital that employs approximately 100 health care professionals. Community Support: Mercy has provided support to the following community organizations in the form of financial support, promotional collaboration and/or colleague volunteer time: United Way of Johnson and Washington Counties Iowa City Hospice Iowa City Free Medical Clinic NAMI (National Alliance for the Mentally Ill), American Cancer Society Mercy partners with School-Based Health Clinics now located in four of the Iowa City Community School District's public schools. The Healthy Kids School-based Health Clinics are free Medical Clinics whose mission is to work collaboratively with area medical partners to provide accessible primary, mental health and specialty care to children from birth through high school graduation who experience barriers to accessing healthcare. Mercy plans to continue to provide staff and/or supplies for first aid booths at community festivals such as Arts Fest, Jazz Fest and Soul Fest as soon as COVID-19 restrictions lift. Mercy has participated in and sponsored these events for multiple years but due to the COVID-19 pandemic in FY20 events were canceled or deemed unsafe for participation. First Aid provided at the Johnson County Fair was also paused in 2020 due to COVID-19, but Mercy has provided this free service for over 10 years and plans to continue as COVID-19 restrictions lift. Rural Health and Safety of Eastern Iowa Partnership providing free COVID-19 testing, rural health screenings, and farm safety campaigns in their efforts to increase health care outreach and reduce injury prevention in the agricultural areas that make up most of its service area. Physical and mental health screenings, injury prevention education and general health information activities are ongoing during the warm weather months in Johnson and five contiguous counties. Mercy continues to be a lead organization for Thanksgiving in July, an annual summer food drive whose goal is to fill food pantries at a time of year when they have fewer donations and children are out of school, not receiving free and reduced breakfast and lunch. This program was started at Mercy Iowa City in 1995 and has grown to include many other sites in the State of Iowa including Des Moines, Dubuque and the Quad Cities. Mercy's Pastoral Care Department provides clothing to patients who are discharged with nothing to wear, often because what they had when they were admitted is no longer wearable (cut off in the Emergency Room, etc.) and there is no one to bring them anything. Transportation is also provided via paid taxi for patients and/or their family members upon discharge as needed due to lack of transportation means. Mercy's 24-hour "Mercy On Call" service provides medical triage and health information, can schedule provider appointments, and refer callers to local supporting services. SHIIP (Senior Health Insurance Information Program) Volunteers help seniors and those on SSDI navigate through Medicare insurance enrollment with emphasis on the annual Medicare Open Enrollment Period. This is a very robust program for the Johnson County area. Environmental Improvements: Mercy has been a good neighbor by maintaining its buildings and landscaping at a high level. Mercy also pursues extensive recycling (including newspapers, office paper, magazines, plastics, batteries, cooking oil, construction materials and more) and programs that reduce energy consumption. Leadership Development and Training of Community Members: Mercy lends support to the annual Community Leadership Program of the Iowa City Area Chamber of Commerce, a nine-month leadership development program for 24 individuals who are increasing their professional and personal commitment to the community and typically sponsors a class member each year. Mercy also supports an active Clinical Ladder program for nurses, offers Continuing Education Credit (CEU) courses and conferences open to medical professionals across the State on a regular basis, such as those tailored to Emergency Care, Hospitalist care and Nursing care. Mercy also offers a location for CEU courses for the local Honoring Your Wishes initiative which encourages all adults to have Advance Directives that are current and reflect their wishes. The CEU courses train individuals to become certified counselors to help individuals with their Advance Directives, and to train certified counselors to assist with IPOST which is the Iowa version of the national POLST directive, a medical order for those with terminal conditions. Honoring Your Wishes is the program used at Mercy, and the hospital offers free assistance to anyone in its service area who needs it to complete the</p>

Mercy is a co-sponsor of the Johnson County SAFE Kids Coalition whose mission is to prevent or reduce preventable injuries to children from birth to age 14. SAFE Kids promotes the correct use of child safety restraints in vehicles, bicycle helmets, and safety education to prevent falls, burns, poisoning and more. Mercy has plans in place to continue its lead partner of Safety Village as done in FY19 into FY21. Safety Village was canceled in FY20 due to COVID-19. It is a two-week summer safety camp for children aged 5-7 held in a miniature village on the grounds of one of our local elementary schools. Mercy Hospital is addressing those needs as follows:</p> <p>Mental Health - Depression and Social Support: Mercy continues to invest in outpatient psychiatric services. While traditional primary care visits fell throughout the COVID pandemic, the visit volume to our mental health clinic grew significantly. We accommodated the growth in demand by initiating telehealth capability at our mental health clinic. We employ four full time providers which includes one therapist. Our providers also staff the emergency room of our hospital in Johnson county where many patients present with mental health conditions. In addition, our affiliate MercyOne will be rolling out a new ambulatory social service this year that will dedicate a social worker to serve as the primary contact for patients with mental health or emotional needs. Their focus is to manage transitions in care following hospital discharges, emergency department use and post-acute stays where mental illness or substance abuse was a primary reason for the admission or visit.</p> <p>Nutrition, Physical Activity, Diabetes: We will continue to offer a 12 week program to the public taught by registered dieticians that focuses on behavioral modifications to achieve long-term lifestyle changes to improve overall health. Since 2018, we have employed a board certified physician in endocrinology, diabetes, and metabolism. His ability to effectively treat patients with metabolic disorders advances our ability to address the adult obesity health need.</p> <p>Substance Abuse - Binge Drinking: Our community is home to a major university and excessive drinking has long been an issue. Our Vice President of Population Health attends the Partnership for Alcohol Safety, a joint project of the University of Iowa and the City of Iowa City. Its mission is to identify and advocate for strategies that reduce high-risk drinking and related harms.</p> <p>Access to Primary Care Physicians: Mercy will continue to operate primary care clinics in each of our 5 primary care counties. This is the most direct way to address access, along with a financial aid policy that reduces the financial barriers for the uninsured. Mercy will also continue support of the Free Medical Clinic in Johnson county. This is an important health care access point for those with limited ability to pay.</p> <p>Cancer - Cancer Incidence : Mercy intends to more widely advertise the low dose lung cancer screening program that screens for at-risk patients, especially former heavy smokers. The existing program has resulted in the early identification and treatment of lung cancers, although many more eligible patients have not yet been screened.</p> <p>Heart Disease & Stroke Mortality Rates: Two additional cardiologists will begin treating patients in 2019 and should result in at least 25% increase in patient contacts with our cardiologists. Mercy is also certified as a primary stroke center and intends to maintain that status.</p>

Injury & Violence - Violent Crime Rate: We intend to take no action as reducing the crime rate is not within the scope of our health care delivery system. Oral Health - Regular Dental Care: We intend to take no action regular dental care is not within the scope of our health care delivery system. Respiratory Disease - Chronic Lower Respiratory Disease: We have employed 2 nurse navigators in 2018, that are focused on reducing hospitalization readmissions and avoidable emergency room visits, especially from patients with chronic conditions. Sexually Transmitted Disease and Chlamydia Incidence: Mercy is continuing to monitor chlamydia incidence rates and has seen recent high rates in the eastern portion of our service area. Our Infection Prevention Coordinator plans to provide staff education in the clinic and identify opportunities for community outreach. He will then track the incidence rates to see if those efforts have a significant impact on reducing incidence. Tobacco Use: We continue to provide smoking cessation counseling to a high percentage (85%) of adult smokers who are seen in our clinics.</p>
