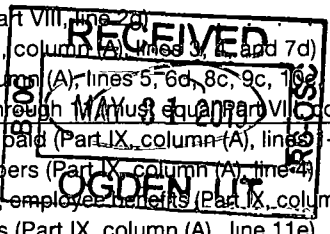

Monitoring the use of grant funds - All contractors are selected through a detailed request for proposal system on a two year cycle. The Grants and Planning Committee review all applications and makes formal recommendations to the Advisory Council. The Advisory Council review the process and recommends it choices to the Board of Directors. The Board of Directors makes the final determination on contract awards. All contracts are monitored on a monthly basis with program and fiscal reports prepared by the contractors. The reports are reviewed before grant funds are paid to the contractors. A formal monitoring visit occurs each fiscal year to review the contract reports, fiscal matters and program compliance issues.
