Monitoring the use of grant funds - All contractors are selected through a detailed request for proposal system on a two year cycle. The Grants and Planning Committee review all applications and makes formal recommendations to the Advisory Council. The Advisory Council review the process and reviews Grants and Planning Committee recommendations. The Advisory Council then prepares their recommendations and forwards the recommendations to the Board of Directors. The Board of Directors make the final determination on contract awards. All contracts are monitored on a monthly basis with program and fiscal reports prepared by the contractors. The reports are reviewed before grant funds are paid to the contractors. A formal on-site monitoring visit occurs each fiscal year to review the contract, reports, fiscal matters and program compliance issues.

PART III - Grants and Other Assistance to Domestic Individuals - Individuals requesting aid must complete an application for assistance at any authorized referral source (are meal sites, housing facility, service center or field office). The application requires personal information, description of the client's financial need, the amount of funds requested, the service requested and their selected vendor. Staff review all applications and verify the information and compliance with funding requirements. The applications are either approved for processing or returned denied.

Approved applications require a detailed invoice from the vendor and all payments are issued directly to the vendor. Examples of assistance provided are utility bills, rent, rent deposits, transportation medical expense, durable medical equipment, homemaker and respite services.
