Student support is a top priority. In FY20, the Organization granted over \$9.5 million to the University of North Dakota to be used to award scholarships to students in the fiscal year. The student support priority to increase endowment support for scholarships will enable the University to recruit and retain top students. During 2020, the worldwide coronavirus pandemic impacted national and global economies. The Organization is closely monitoring its operations, liquidity and capital resources and is actively working to minimize the current and future impact of this unprecedented situation. All fundraising events occurring after March 2020 including the Champions Ball for FY20. Additionally, in FY20, we started 2 fundraising initiatives to support students during COVID.
