We are united to serve the Mission and, as a team, build communities within our ministry; Stewardship, being responsible stewards of our resources: human, physical, and financial. Today, Prairieland Home Care in conjunction with Sisters of Mary of the Presentation carries out the mission to provide home care to those who are less fortunate and in need. As a not-for-profit, Catholic Healthcare organization, we treat patients, regardless of their ability to pay. This is consistent with our mission and the Core Values of the Sisters. In addition, Prairieland Home Care provided thousands of dollars in resources, including time and contributions to many throughout the region. Community service is a vital component of Prairieland since its inception. To fulfill the mission of community service, the Organization provides care to patients who meet certain criteria under the charity care policy without charge or at amounts less than its established rates. Revenue from services to these patients is recorded in the accounting system at the established rates, but the Organization does not pursue collection of the amounts. The resulting adjustments are recorded as adjustments to patient service revenue, depending on the timing of the charity determination. The Organization provides services to other medically indigent patients under certain government-reimbursed public aid programs. Such programs pay providers amounts which are less than established charges for the services provided to the recipients, and for some services the payments are less than the cost of rendering the services provided.
