Nutrition and Emergency Assistance and Services Surplus commodity distribution (TEFAP & CSFP) provide monthly distributions of surplus USDA commodities to elderly and disabled households. Self-Sufficiency programs are provided as a goal orientated case management designed to assist low income & disadvantaged individuals decrease government dependency. Goals addressed may be employment, education, housing or money management related. These programs include HIV prevention, voluntary income tax assistance (VITA) and individual development accounts (IDA). Children Services A full day, year-round child care center is provided for low-income families and families whose children are enrolled in head start with the goals to help children develop emotionally and socially, encourage self-confidence, self-expression and self-discipline, and promote curiosity. SENDCAA provides children services including mental health. Its major sources of revenue consist of various federal, state and other grants. Community Housing Development Organization (CHDO) The CHDO monitors compliance and payments on funds advanced for the development of affordable housing. Being a CHDO allows SENDCAA to receive additional allocated funds for affordable housing development.
