Avera Sacred Heart is a 501(c)(3) organization affiliated with Avera Health. 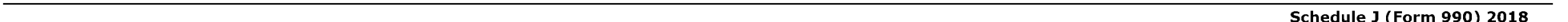
