The allocation is retired and paid to the member at the discretion of the Board of Directors of Cherry-Todd Electric Cooperative, Inc.

The bylaws provide an election be held annually for the Board of Directors' positions that are expiring. The balloting for the election is held during the annual meeting. Therefore, the representation of the Board of Directors is decided by the votes of the members.
