Many events were done in cooperation with other arts and community organizations. Concessions are sold at most events. This year's live programming in March 2020 due to shutdowns related to COVID-19. ZADT conducted a reduced level of streaming programs that were free for the public during this mandated shutdown.

The Executive Director and Chairman monitor and enforce the Conflict of Interest Policy by having the Executive Director and Directors disclose interests that could give rise to conflicts. The Executive Director and Directors sign a Conflict of Interest Form Annually.

Part VI, Line 15 - Process for Determining Compensation:

ZADT has no key employees, as defined. However, ZADT used an industry compensation survey and discussion/approval by the Board of Directors to establish the Executive Director's compensation. The organization does not compensate officers or directors.

Part VI, Line 19 - Public Disclosure of Documents:

ZADT makes governing documents, conflict of interest policy, and financial statements available to the public upon request.
