EDPNC's travel and tourism division, Visit North Carolina, promotes the state's tourism appeal and industry, which supports more than 219,000 jobs and 45,000 businesses in North Carolina. Visit NC executes marketing programs that advance North Carolina's standing as a major destination for leisure travel, group tours, meetings and conventions, sports events, film production and retirees. The marketing efforts of Visit NC and its public and private partners at the state, regional and local levels have been successful. The latest available figures for calendar 2016 show record growth in domestic U.S. visitor spending in North Carolina at \$22.9B, an increase of 4.4% over the previous year.

Form 990, Part III, Line 4b:

The EDPNC's international trade division helps NC companies identify and develop overseas marketing opportunities free of charge. This is especially beneficial to smaller businesses which often do not have staff dedicated to exploring and developing export opportunities. EDPNC has multilingual experts located in North Carolina and several foreign offices in Canada, Mexico, Europe, South Korea, Japan, Shanghai and Hong Kong. Services offered by the international trade team include export education programs, customized searches for international distributors or agents, research and intelligence on international markets and referral to programs offering export finance assistance. The team organizes and leads North Carolina companies' participation in high-profile international trade events. The team also helps participants access federal funding to cover certain costs, including travel and marketing material translation. The division's services include introducing businesses to potential buyers and distributors of their products or services. EDPNC international trade experts assisted over 558 NC companies export over \$832M in sales in calendar 2016.

EDPNC's business recruitment division helps grow North Carolina's economic base by securing new facilities (projects) that lead to increased employment opportunities throughout the state. This division works statewide helping companies interested in locating or expanding in North Carolina find sites, navigate financial incentives and permitting requirements, and identify and tap resources to meet workforce, training and infrastructure needs. The EDPNC and its partners supported 139 announced business recruitment and expansion projects in calendar 2016, resulting in 14,944 announced new jobs and \$3.84 billion in announced capital investment in North Carolina.
