NWSP focused on four (4) main areas of economic and community development to include (1) safety, (2) housing, (3) commercial corridor development, and (4) neighborhood identifying and branding. Safety is a major priority and in this year NWSP was able to continue to work closely with the Milwaukee Police Department, District Attorney and Marquette University Police Department providing support and guidance to the local community. NWSP also has continued to purchase properties under real estate transactions with the end goal of supporting catalytic development on a prominent intersection. Our featured program to assist in the revitalization efforts of the Near West Side is Promoting Assets Reducing Crime (PARC). This multi-year and multi-million program supports the efforts of highlighting community based assets. Promoting Assets Reducing Crime Program focuses on (1) promoting the assets of the local community including historic neighborhood buildings, businesses, people and events such as the Historic Concordia Neighborhood Tour, the Near West Side Farmer's Market, housing incentive strategy called "Live, Work, Play" etc and (2) strategies that reduce crime including working with the District Attorney in a unique partnership to address place and people based strategies, sponsoring programming like the Near West Side Landlord Compact, the Near West Side Partners Security Ambassador program with two full time security ambassadors, the Lighting Challenge providing funds for residents to improve lighting and the Near West Side Surveillance Program providing funding for both commercial and residential property owners for surveillance cameras. In other areas NWSP has focused on providing platforms for art, business recruitment, and streetscape planning as tools for economic development and growth.
