Facilities support - Construction, furnishings and equipment funded by private giving fluctuates from year to year depending on the timeline of construction projects. This fiscal year saw the completion of the Stauffer-Flint Hall, School of Journalism and Mass Communications, renovation. More than two-thirds of the University of Kansas buildings and about 85% of the land available for campus expansion were made possible by private gifts.
