Facts And Circumstances Test

The Eleutherian Mills-Hagley Foundation ("Hagley"), a nonstock, not-for-profit educational corporation was incorporated in the State of Delaware on November 3, 1952. Donations of property made at that time and subsequently by eight different donors totaling approximately 235 acres. The Eleutherian Mills-Hagley Foundation gave notice of intent to terminate Private Foundation status under section 507(b)(1)(B) for a sixty-month period beginning January 1, 1975 through December 31, 1980. Notification was received from the Internal Revenue Service on June 5, 1980 that Hagley had been classified as an organization described in Section 509 (a)(1) and 170(b)(1)(A)(vi), under the "facts and circumstances" test. Hagley's property has been an industrial site since at least the beginning of the nineteenth century, and contains approximately 85 buildings and 93 site structures of varying size and condition of repair, relating to industrial and residential life of the 19th and early 20th centuries. The Hagley Museum and Library was opened to the public in 1957 and since that time visitation has exceeded 5,000,000. It is presently open to the public 363 days a year. Hagley Museum holds 60,000 objects, including a large collection of U.S. patent models, early American furniture and textiles, and a major collection of advertising art. Museum programs include special tours for school groups conducted by a corps of professionally trained guides. The Library at Hagley traces its origins to the old Longwood Library that was established by Pierre S. du Pont in 1954. In 1961 it merged with the Hagley Museum and moved its present site on the banks of the Brandywine. Today its research collections hold the archives of more than 1,000 businesses in more than 38,000 linear feet of manuscript records, more than 290,000 published sources, more than 2 million audiovisual items, and more than 320,000 digital artifacts which preserve an invaluable record of American business, technological, and social development. Hagley's main strength is in the Middle Atlantic region, but in recent years the scope of its collecting has broadened to include records of and works about business organizations and companies with national impact. The Library's national stature was recognized in 1985, when it was granted membership in the Independent Research Libraries Association (IRLA). The Center for the History of Business, Technology, and Society, a department of the Library, was founded in 1975 to encourage and coordinate research in Hagley's areas of research and collecting interests. The Center sponsors conferences, colloquia, and seminars and it issues publications. Since 1977 it has awarded competitive research fellowships to more than 700 scholars from around the world. The BHOC continues a beneficial relationship with the University of Delaware. Since 2015, a "Hagley Does History!" course has been offered through the University of Delaware's Osher Lifelong Learning Institute to enrollees of all ages. Hagley's principal support has historically come from endowments. Since 1978, with the formal creation of a development office, Hagley has increased its fund-raising activities to include the active solicitation of individuals, corporations, foundations, as well as state and federal government agencies. The planning and coordination of all fund-raising programs for endowment operations and special projects are now centralized. A general membership program known as "Hagley Associates" was formed in 1975 to encourage further community support for Hagley. The number of Hagley Associates' memberships for 2019 totaled approximately 3,000. A business membership program, known as "Corporate Associates", was formed in 1982. One of the benefits of being a corporate member is being able to rent Hagley's rooms and facilities for business meetings. The number of corporate associates for 2019 totaled approximately 100. The Foundation is governed by a board of fourteen trustees including not only leaders in the local community, but also specialists in several fields pertinent to Museum and Library operations.
