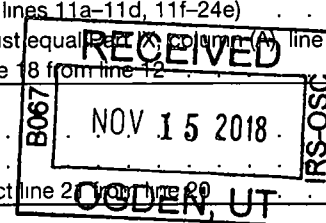

AHA IN RURAL APPALACHIA IS DEDICATED TO POVERTY- STRICKEN FAMILIES, CHILDREN AND ELDERLY OR DISABLED ADULTS TO MEET THEIR EMERGENCY NEEDS AND STRENGTHEN THEIR EFFORTS TO BE SELF-SUFFICIENT.

FOOD AND BASIC NEEDS - AHA PROGRAMS TARGET THE EMERGENCY NEEDS OF SEVERELY POVERTY-STRICKEN FAMILIES AND INDIVIDUALS IN RURAL APPALACHIA. BASIC NEEDS, SUCH AS FOOD, NEW SHOES, COATS, BLANKETS, HYGIENE ITEMS, UTILITY AND RENT ASSISTANCE ARE PROVIDED TO FAMILIES, DISABLED AND ELDERLY WHO ARE LACKING DUE TO THEIR ECONOMIC AND PHYSICAL LIMITATIONS. AHA ALSO PROVIDES SCHOOL SUPPLIES AND AFTER SCHOOL PROGRAM SUPPORT FOR CHILDREN. THE HIGH LEVEL OF UNEMPLOYMENT AND POVERTY THAT EXISTS IN THESE RURAL AREAS COMBINED WITH FEW LOCAL RESOURCES CREATES A TREMENDOUS NEED FOR THIS TYPE OF ASSISTANCE.
THIS YEAR, AHA DONATED 30,212 LBS. OF TURKEYS FOR THANKSGIVING AND CHRISTMAS AND 6,042 INDIVIDUALS BENEFITED FROM THE FOOD BANK SUPPORT.
AHA PROVIDED 2,450 NEW COATS, 1,630 BLANKETS, 4,950 BACKPACKS CONTAINING SCHOOL SUPPLIES FOR ELEMENTARY AND AHA PROVIDED 2,450 NEW COATS, 1,630 BLANKETS, 4,950 BACKPACKS CONTAINING SCHOOL SUPPLIES FOR ELEMENTARY. (SEE SCHEDULE O FOR CONTINUATION)

YOUTH DEVELOPMENT - SUMMER TIME MEANS NO SCHOOL, NO HOMEWORK, AND THREE MONTHS OF FUN FOR CHILDREN ALL AROUND THE U.S. FOR MANY CHILDREN IN APPALACHIA; IT ALSO MEANS A SIGNIFICANT AMOUNT OF TIME SPENT UNSUPERVISED, WITH VALUABLE ENRICHMENT OPPORTUNITIES LOST, AND SOMETIMES A LACK OF NUTRITIOUS MEALS DURING THE DAY. AHA'S SUMMER CAMP PROGRAMS PROVIDED A HEALTHY, EDUCATIONAL, TROUBLE-FREE OUTLET FOR 224 CHILDREN TO ATTEND CAMPS IN KENTUCKY, TENNESSEE AND WEST VIRGINIA. MANY OF THESE CHILDREN ARE FROM VERY LOW-INCOME FAMILIES ON A FIXED INCOME WHO, WITHOUT THE ASSISTANCE OF AHA'S SUMMER CAMPS SPONSORSHIP PROGRAMS, WOULD BE LEFT WITHOUT POSITIVE AND WHOLESOME ACTIVITIES TO PARTICIPATE IN DURING THE SUMMER.
AHA PROVIDED \$21,000 IN CASH GRANTS TO AID CHILDREN ESCAPING THEIR WORLD OF POVERTY BY MAKING SURE THEIR SUMMER CAMP EXPERIENCE OFFERED COMMITTED MENTORS, EDUCATIONAL OPPORTUNITIES, AND HEALTHY MEALS DURING THE SUMMER MONTHS. (SEE SCHEDULE O FOR CONTINUATION)

HOUSING/SHELTER - A HOME WITH MORE PEOPLE THAN ROOMS AND NO INDOOR PLUMBING IS CLASSIFIED AS SUBSTANDARD. AHA HAS DEVELOPED A VARIETY OF PROGRAMS WORKING WITH LOCAL RESIDENTS IN COLLABORATION WITH CHURCHES AND LOCAL PUBLIC AND NON-PROFIT AGENCIES TO ADDRESS SOME OF THE MOST CRITICAL NEEDS FACED BY APPALACHIAN COMMUNITIES. POVERTY IN APPALACHIA HAS PERSISTED THROUGHOUT THE NATION'S ECONOMIC BOOM FOR YEARS UNEMPLOYMENT REMAINS THE HIGHEST IN THE COUNTRY, WHERE ILLNESS AND MALNUTRITION ARE THE MOST PERSVASIVE, AND TOO MANY CHILDREN HAVE NO SHOES AND LIVE IN RUN DOWN HOMES, OFTEN WITHOUT HEAT AND LITTLE NUTRITIOUS FOOD TO EAT.
WORKING WITH LOCAL AND NATIONAL VOLUNTEERS, AHA ASSISTED 67 HOME RENOVATION /REPAIR PROJECTS FOR LOW-INCOME FAMILIES, ELDERLY AND DISABLED INDIVIDUALS. AHA HAS WITNESSED FIRST-HAND HOMES WITHOUT ROOFS, MISSING WALLS, AND HUGE HOLES IN THE WALLS AND FLOORS OF HOMES. (SEE SCHEDULE O FOR CONTINUATION)
