STAYING ON TOP OF ONE'S ELECTRICAL BILLS IS SIGNIFICANT TO AVOID GOING DEEPER INTO POVERTY. HOLIDAY FOOD EVERY YEAR, FAMILIES WOULD FORGO EXPENSES AND SAVINGS JUST TO HAVE A TRADITIONAL THANKSGIVING OR HOLIDAY MEAL AND PRESENTS. THIS USUALLY BRINGS HIGH EVICTIONS AND SHUT-OFFS IN JANUARY WHEN THE POOREST COMMUNITIES ARE UNABLE TO PAY UP. AMERICANS HELPING AMERICANS WAS ABLE TO GRANT \$28,800 IN FY2020 TO OUR COMMUNITY LEADERS IN WEST VIRGINIA, TENNESSEE, KENTUCKY, AND GEORGIA TO DELIVER TURKEYS AND HOLIDAY MEALS TO 6,132 PEOPLE. THANKSGIVING DINNERS AND CHRISTMAS CELEBRATIONS WERE STARTED FOR ALL FAMILIES TO COME TOGETHER AND SHARE A MEAL, SO THAT NO ONE WOULD HAVE TO STRESS THEIR FINANCES TO HAVE A DELICIOUS MEAL. GRANTS WERE GIVEN TO EACH PARTNER TO BUY THE TURKEYS LOCALLY AND VOLUNTEER LABOR HELPED ORGANIZED ALL THE EVENTS.THREE COMMUNITY GARDENS AND NINE INDIVIDUAL GARDENS WERE SPROUTED UP WITH AHA'S NEW INITIATIVE TO BRING GREATER FOOD SECURITY TO APPALACHIAN COMMUNITIES. AGRICULTURE EDUCATION CURRICULUM WAS DEVELOPED BY OUR NEWEST PARTNERS IN ORDER TO TEACH COMMUNITY RESIDENTS HOW TO GROW, MAINTAIN, SELL, THEIR PRODUCE AS WELL AS RECOMMEND HEALTHIER NUTRITIONAL EATING HABITS. OUR 'FOOD SUSTAINABILITY' INITIATIVES PROVIDED ONE PAID JOB AND MANY HOURS OF VOLUNTEER LABOR.

TO ENSURE THE YOUTH RECEIVES THE SUPPORT THEY NEED TO PERFORM WELL IN SCHOOL, AHA PROVIDED 3,549 BACK PACKS FILLED WITH SCHOOL SUPPLIES AND SPONSORED AFTER SCHOOL PROGRAMS WHICH PROVIDED HEALTHY MEALS AND TUTORING SERVICES WITH \$17,000 IN GRANTS ASSISTING 1,562 CHILDREN. DIGITAL DIVIDE: AHA PROVIDED 30 LAPTOP COMPUTERS TO BEATTYVILLE ELEMENTARY IN LEE COUNTY KENTUCKY FOR STUDENTS TO TAKE HOME AND CONTINUE THEIR EDUCATION FROM HOME. MANY ROADS IN BEATTYVILLE ARE LOOSE GRAVEL AND WHEN SNOW STORMS COME THROUGH DEPOSITING SEVERAL INCHES, THOSE ROADS DO NOT GET CLEARED LEAVING FAMILIES STRANDED AND SCHOOLS CLOSED. PARENTS CAN USE THE COMPUTERS TO APPLY FOR JOBS ONLINE AS WELL.
