Grants and Funding ADF provides grant funding for legal cases and programs that keep the door open for the Gospel by advocating for religious liberty, the sanctity of life, and marriage and family. This grant funding covers expenses for litigation, including training for expert witnesses and acquiring strong amicus brief support for our cases to ensure the best possibility of success. Grant requests are reviewed and recommended by an independent grants and review committee, which is comprised of expert volunteer attorneys. Under the governing Board of Director's policy, no grant is awarded until it is fully funded and set aside in self-designated accounts. Grants are disbursed upon performance and in accordance with the terms of the grant agreements. As of this writing, ADF has issued more than 3,200 grants totaling over \$48 million.
