Part V, Line 2(1): CADCO Foundation granted \$191,573 to Capital Area Development Corporation of West Virginia (CADCO) for support of its business incubator building.

Part V, Line 2(2): Enterprise Properties granted \$125,000 to CADCO Foundation for economic and community development programs.

Part V, Line 2(3): CADCO owes a note payable to CADCO Foundation to repay funds borrowed from the Foundation's board-designated endowment for the purpose of improvements to the business incubator building owned and operated by CADCO. Funds are repaid semi-annually to the Foundation's endowment account based on an amortization schedule computed with a competitive fixed rate of interest. At 12/31/17, the balance of the note payable was \$204,394. Payments to CADCO Foundation on this note in 2017 were \$23,751 including interest of \$6,414.

Part V, Line 2(4): CADCO Foundation pays nominal membership dues of \$365 annually to CADCO. All administrative and management functions of CADCO Foundation are performed by CADCO staff without charge to CADCO Foundation.

Part V, Line 2(5): As is common with related organizations managed by shared staff and utilizing shared resources, CADCO Foundation, and its affiliate, CADCO, use an intercompany due to/from account to capture transfers and other transactions during the normal course of recordkeeping. The net increase in the Foundation's payable to CADCO in 2017 was \$3,405.
