Part V, Line 2(3): CADCO owes a note payable to CADCO Foundation to repay funds borrowed from the Foundation's board-designated endowment for the purpose of improvements to the business incubator building owned and operated by CADCO. Funds are repaid semi-annually to the Foundation's endowment account based on an amortization schedule computed with a competitive fixed rate of interest. At 12/31/19, the balance of the note payable was \$168,158. Payments to CADCO Foundation on this note in 2019 were \$23,751 including interest of \$5,368.

The net increase in the Foundaton's payable to CADCO in 2019 was \$2,472.
