Community-based programs-SalusCare offers several community-based programs thus allowing patients and families to be served in their homes or at other locations within the community. Most notably, the Community Action Team (CAT) which provides comprehensive, community-based services to children up to age 21 with a mental health diagnosis or co-occurring substance abuse diagnosis who are at risk for an out-of-home placement, poor academic outcomes or other serious factors. In 2018, 76 families were served in this program. Therapeutic Behavioral On-Site (TBOs) services are also available in the community, including case management services, parenting and evidence-based prevention programs. In this program, SalusCare served 179 patients in 2018. SalusCare also works closely with the Lee County School District to help identify children at-risk and in need of behavioral healthcare services.
