The Weatherization Assistance Program enables low-income families to reduce their energy bills by making their homes more energy efficient. One of the primary factors affecting eligibility is income. Clients are eligible for weatherization if their income falls below the 200% poverty level. In addition to income, preference is given to people over 60 years of age, families with one or more members with a disability, and families with children.
