CONSISTS OF LIFE LEARNING CAMPUS FOR THE POOR, HOMELESS, AND AT RISK IN WEST CENTRAL FLORIDA COMMUNITIES (LAKELAND, WINTER HAVEN/AUBURNDALE, PLANT CITY, BRANDON, YBOR CITY/TAMPA). OUR PURPOSE IS TO OFFER DIGNITY AND A BETTER QUALITY OF LIFE THROUGH THE POWER OF THE GOSPEL FOR THOSE WE SERVE. WE OFFER OPPORTUNITIES WITH TWO OBJECTIVES: RESCUE AND RECOVERY. RESCUE INCLUDES OVERNIGHT SHELTER, HOPE CENTERS, COMPASSION CONNECTIONS, AND HOMELESS INTERVENTION.
