The Frontlines Director sends the contract to the Finance Department to file into DropBox and issue the mini grant check to the appropriate recipient. Grantees are expected to complete a simple grant report, which is then filed in Powerbase. Recipients should submit grant reports to the Frontlines Fund Director for the appropriate program. For other grants, we require a report of activities and how funds were spent. We track reports through Powerbase (database management system).
