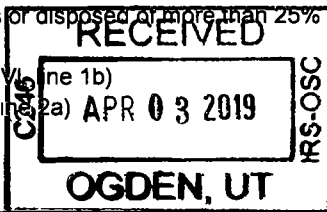

The Hunter Museum of American Art presents dynamic and accessible experiences for visitors through a comprehensive collection of more than 5,000 works, broad-ranging exhibitions, and more than 100 educational programs for children and adults

Utilizing the strong permanent collection and temporary traveling exhibitions, the museum connected with over 61,000 visitors in fiscal year 2018, and has engaged the community through a wide variety of programs and events. For example, in 2018, our temporary exhibition, New Media, New Millennium Digital Art from the Thoma Foundation, was further explored in our permanent collection spaces through installations of our own technology based works, and our summer exhibition, Embodied Beauty. Sculptures by Karen LaMonte was a Hunter organized exhibition on an artist who has been in the museum collection since 2008. Several permanent collection galleries have been reinstalled since mid-2015, projects included research and physical updates to exhibition spaces

The curatorial and educational departments continually work together to develop gallery experiences for all guests. Efforts include the ongoing Art Issues series, a vibrant program attracting diverse speakers and audiences that directly responds to the strategic initiative to engage diverse cross sections of the community with the collection. The monthly Artful Yoga series reached a different demographic with 40 to 50 people attending each month. Finally, the Art Wise Distinguished Speakers series featured respected artists and scholars from around the globe. Annual student visitation remained strong with approximately 8,200 K to 12 students served as well as an additional 1,200 college students. The museum provides hands on programming with deeper engagement opportunities for students in Title 1 schools. The Hunter served youth through in studio experiences and summer camps and offered three Family Fun Days to attract the whole family to the museum. Free admission for all youth 17 and younger and free First Thursdays made the museum more accessible to a wid

The Hunter values collaboration and demonstrates this through numerous partnerships. The museum plans, implements, and assesses approximately ninety percent of its public programs in partnership with cultural, civic, activist, social, and professional organizations. The Hunter is an active partner in ArtsBuild Chattanooga, sending a senior employee to each Partners meeting and assigning its development staff to work at the annual two night telethon. Additional current partnership initiatives include teen programs developed with the Creative Discovery Museum, a medical school partnership with UT College of Medicine at Erlanger, collaborations with Reflection Riding Arboretum and Nature Center and the Chattanooga Library, and shared departments with the Tennessee Aquarium including human resources, information technology, museum store inventory purchasing, and finance
