Railroad Park is a 19 acre green space in downtown Birmingham that celebrates the industrial and artistic heritage of our great city. Situated along 1st Avenue South, between 14th and 18th Streets, the park is a joint effort between the City of Birmingham and the Railroad Park Foundation. Hailed as "Birmingham's Living Room," Railroad Park provides a historically rich venue for local recreation, family activities, concerts, and cultural events, while connecting Birmingham's downtown area with Southside and UAB's campus. During 2019, there were approximately 515,000 visitors to the park. Railroad Park has been the catalyst for tremendous change not only in the physical landscape of Birmingham, but also in the perception of what Birmingham can be. In 2019, Railroad Park Foundation continued to focus on three primary goal areas: Economic Development, Family and Community, and Health and Wellness.
