REEF links the diving community with scientist, resource managers and conservationist through marine-life data collection and related activities.

This data is used to better understand and protect ocean ecosystems worldwide. Fisheries protection around the world depend on high-quality data. With REEF data submitted by citizen scientists, researchers are making exciting discoveries about marine ecosystems, and policy makers have more information to refine conservation efforts.

**Education and outreach:** REEF provides education and outreach activities to build and inspire a community of ocean stewards. We conduct online programs such as webinars with interactive content. We also conduct in-person programming led by REEF staff as well as the wide network of partners including dive shops, clubs, nature centers, and public aquaria.
