ANIMAL CARE & ADOPTIONS This year, ARF adopted 2,665 cats and dogs. Each animal is behaviorally and medically evaluated, medically treated as needed, spayed or neutered, and microchipped prior to adoption. Dogs and cats are well cared for and safe at ARF while they await new loving homes.

CLINIC ARFs clinic provides medical care and surgeries for animals rescued and adopted out by the organization. Through its public spay and neuter programs, ARF reduces the oversupply of companion animals by preventing breeding of pets in Contra Costa County, and provides low-cost spay and neuter surgeries to community members and other rescue organizations. Through ARFs mobile Clinic, low-cost spay and neuter surgeries are provided to the public. ARF performed 3,900 surgeries this year which helps break the cycle of companion animal overpopulation. The mobile Clinic also provides free wellness care, vaccinations, and spay and neuter surgeries to pets belonging to veterans of the U S military at local VA campuses, and charitably provided services to 845 pets. Through ARFs Emergency Medical Fund, 133 veterinary care exams were provided for 102 cats and dogs belonging to low income residents of Contra Costa County, California, helping to keep pets in their existing homes.
