JBU committed to use no less than 50% of total funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, healthcare, and child care). After first distributing funds through the application process, the remaining funds were distributed based on student financial need. JBU distributed \$658,170 to 861 students.
