DAY SHELTER - The Day Center is the only day time shelter in Tulsa County. We provide a safe, secure environment for anyone who seeks help or who has been referred. Everyday approximately 400 people, including men, women, families, the elderly, individuals who have mental illness, as well as, people with developmental and physical disabilities seek shelter at the Day Center. Our emergency shelter program provides a safe place to rest, food, restrooms and bathing facilities, personal care items, laundry facilities and a change of clothing. Clients may also make and receive phone calls, receive mail and store personal items in a locked storage area. At night the Great Room of the Day Center transitions into our Night Shelter. Each night we provide shelter for approximately 115 of the most vulnerable and at-risk segment of the homeless population. This includes women, those who suffer from mental or physical illness and men over 55. Both the Day Center and Night Shelter are open 365 days a year. The Day Center hours are from 8:00AM to 4:00PM. Night Shelter hours are from 4:00PM to 8:00AM

CLINIC: We have a free Nurses Clinic on site. The clinic is under the supervision of an APRN and is staffed by three full time RNs. By providing low barrier access to improved medical care, along with the supplies necessary to self-manage their medical needs, clients are able to improve their health and continue working toward self-sufficiency. Homelessness and health care have a cyclical relationship: Poor health can lead to homelessness and homelessness can lead to poor health. The clinic staff remains dedicated to helping each individual with however much care and time is needed. This Clinic has been very successful in preventing unnecessary ER visits to community hospitals. We have a parttime Doctor who visits the clinic two half days a week. The clinic offers vision screening weekly staff by volunteer Doctor. On a monthly basis a Podiatrist aids clients with foot care. During 2017 there were 14,428 client visits. 7,701 for Triage visits, 1,834 APRN visits, 1,801 TB test given, 906 referrals made by APRN, 379 ER visits averted.

HUDSON VILLAS: Hudson Villas is a 60-unit affordable housing apartment complex, now called home to formerly homeless individuals. The objective is to provide decent, affordable housing in a suitable living environment with onsite support services to help those who have faced complex challenges in exiting homelessness. We provide support services to assist tenants in achieving residential stability, improved health and quality of life. Life skills classes are offered. Case Managers work one on one and in group settings to increase employment abilities, increase income, manage health issues and expand resident participation in the community. This targeted one on one support prevents recurrence of homelessness.

barriers. Case managers had over 14,886 counseling contacts in 2017. They assisted 396

individuals applying for birth certificates or other forms of identification to enable that

person to seek employment or housing. 441 clients were assisted in filling out a housing

application with 234 of those successfully becoming housed. Through the Case Management and

Eviction Prevention program, every client has access to individualized general and mental

health case management.
