Our Integrative Medicine program included acupuncture, herbal medicine, nutrition, Tai Chi, bio-feedback, and therapeutic massage. Our nationally-recognized Hope for Heroes program provided military competent counseling, workshops, and integrative medicine to veterans, service members, and their families. In addition, we provided programming and peer support to veterans who are incarcerated.
