THE HAPPY WHEELS HOSPITALITY CARTS STROLL THE HALLWAYS OF FIVE CENTRAL TEXAS HOSPITALS PROVIDING COMPLIMENTARY BEVERAGES, SNACKS, SMALL TOYS, AND TOILETRIES TO FAMILIES OF HOSPITALIZED CHILDREN. DURING 2020, ITEMS WERE DISTRIBUTED TO 9,809 INDIVIDUALS IN CENTRAL TEXAS. DUE TO THE COVID 19 PANDEMIC, THE RMHC CTX GLOBAL OFFICE INSTRUCTED ALL CHAPTERS TO SUSPEND OPERATING THIS PROGRAM AS OF MARCH 13, 2020. AS AREA COVID 19 RISK LEVELS DECREASED, RMHC CTX BEGAN WORKING WITH STAFF AT EACH OF THE HOSPITALS TO REINSTATE THE PROGRAMS. AS OF DECEMBER 31, 2020, FOUR OF THE FIVE HAPPY WHEELS HOSPITALITY CARTS WERE SERVING FAMILIES.
