Footnotes

Statement 1

The 990-T return is to claim a refund of estimated taxes paid on transportation and parking fringe benefits provided to employees. Under Section 512(a)(7) per Taxpayer Certainty and Disaster Tax Relief Act of 2019 found in Division Q of the Further Consolidated Appropriations Act, 2020 (H.R. 1865) signed into law on December 20, 2019, the act retroactively repeals Section 512(a)(7) of the Internal Revenue Code that expanded the definition of unrelated business taxable income to include certain transportation parking fringe benefits to employees.
