Camp Allen Camp and Conference Center is a modern year-round facility located one hour northwest of Houston. The lodging and conference center are located in a beautiful pine forest with rolling hills and two lakes. Camp Allen accommodates a variety of spiritual and educational events for all ages. Our experienced management team share a passion for service and Christian hospitality. Camp Allen is a leader in the Camp, Conference and Retreat Center ministry. The Camp covers more than 1,100 acres and includes a conference center and camp facilities. Over 47,500 attended a variety of programs on music, art, spiritual, leadership, and family retreats. Over 15 universities, 221 churches, and 129 other non-profits attended these programs in 2017.

The Summer Camp program covers ages 3rd grade to high school. These programs are one week summer camp sessions. During 2017, over 1950 campers attended the programs from all over the State of Texas.
