THE ORGANIZATION PROVIDES MEDICAL SERVICES AND MINOR PROCEDURES FOR CHILDREN AND ADULTS. SPECIALTY MEDICAL SERVICES INCLUDE ONCOLOGY, DYSPLASIA, CARDIOLOGY AND COMPREHENSIVE PRENATAL CARE INCLUDING ULTRASOUND AND CHILDBIRTH. SERVICES ARE RENDERED IN ENGLISH AND SPANISH. IN 2019 THE ORGANIZATION'S MEDICAL SERVICES HAD 11,275 PATIENTS AND 30,871 ENCOUNTERS/MEDICAL VISITS.

THE ORGANIZATION PROVIDES DENTAL SERVICES FOR CHILDREN AND ADULTS. THESE SERVICES INCLUDE EXAMINATIONS, PROPHYLAXIS, SEALANTS AND SURGICAL PROCEDURES AS WELL AS REHABILITATIVE AND RESTORATIVE SERVICES. IN 2019 THE ORGANIZATION'S DENTAL SERVICES HAD 825 PATIENTS AND 1,814 DENTAL ENCOUNTERS/VISITS.
