 Education Programs North Branch Nature Center served more than 2,600 people in 2016 through six programs including Forest Preschool, Summer Nature Camps, ECO (a standards-based program in collaboration with nine area public schools), and ECO Teacher institute, offering graduate-level for-credit courses for professional educators. We emphasize hands-on experiential education, offering opportunities to practice outdoor living skills and learn natural history while developing a lasting relationship with the natural world and fostering a sense of a place and stewardship in our local Vermont communities

4b (Code) (Expenses \$ 38,654 including grants of \$) (Revenue \$ 35,844)
 Public Natural History Programs Birdfest and caterpillar day are our two most popular annual inter-generational events, each drawing more than 200 attendees. Our naturalist journeys Lectures and slide shows draw crowds of 50 to 125 attendees on mid-winter Friday evenings to hear speakers from around new england. Recent topics have included polar exploration, shark conservation, and photo-safari in Botswana. We also lead bird watching trips around Vermont and beyond, including to Texas, New Jersey, Maine, Nicaragua, and Costa Rica

 Citizen Science Hands on citizen science opportunities include amphibian rescue and monitoring, monarch butterfly tagging, and bird count programs. As one example, in the autumn of 2015, approximately 235 people attended a series of night-time saw-whet owl bandings, contributing much-needed data on this little known migrating bird. 123 owls were banded and their migration progress is being tracked as some individuals are re-netted in banding programs to the south
