As the Continuum of Care Coordinator for Monterey County, the Coalition of Homeless Services Providers (Coalition) continues to facilitate efforts to end homelessness, such as the successful application for Homeless Prevention and Rapid Re-Housing Program (HPRP) funding for the City of Salinas and Monterey County through Federal Stimulus Funding, and the annual Department of Housing and Urban Development (HUD) Continuum of Care Notice of Funding application. These funds combine to prevent and address recent recession-related spikes in homelessness and those at-risk of homelessness by bringing funds into our community. The Coalition also administers the HUD-mandated Homeless Management Information System (HMIS) database. As of May 2011, San Benito County was officially recognized by HUD as a part of the Monterey/San Benito Continuum of Care. The Coalition, as lead agency, contracted with Home Base to complete the Monterey/San Benito County Ten Year Plan to End Homelessness ("Lead Me Home"). The project planning stage was completed in June 2011 and we are in the process of implementing the Plan.
