To prepare for the long term stewardship of the future park, Friends works with the City of Seattle to beautify and program existing waterfront public spaces. Through its pilot project, Hot Spot, Friends gathers data and experiments with diverse programming and partnerships to inform the future park operations and activation strategies. Working with over 40 community partners, Friends leads cultural and recreational programs on summer weekends July- September with free events attended on average by 300 people. The first piece of the park, Pier 62, will open in 2019 and Friends will program the park in partnership with the city. Friends is also fundraising to support capital costs of the entire park to open in 2023.
Friends created and operates Waterfront Space, a public program and exhibit
