HOUSING DEVELOPMENT PROVIDES AFFORDABLE HOUSING OPTIONS TO PEOPLE AND FAMILIES WITH LOWER INCOMES THROUGH DEVELOPMENT OF SINGLE-FAMILY AND MULTI-FAMILY HOUSING PROJECTS AND PRESERVATION OF EXISTING HOUSING PROJECTS. HOUSING DEVELOPMENT IS ALSO RESPONSIBLE FOR THE FORMATION OF TAX CREDIT PARTNERSHIPS AND OTHER LEGAL ENTITIES CREATED FOR THE PURPOSE OF OWNERSHIP AND DEVELOPMENT. COSTS INCLUDE PREDEVELOPMENT EXPENSES ASSOCIATED WITH NEW AND/OR REHABILITATED HOUSING, STAFFING AND CONSTRUCTION MANAGEMENT COSTS. SINCE 1997 THE ORGANIZATION HAS SERVED OVER 12,500 INDIVIDUALS WITH COUNSELING SERVICES, WITH OVER 1/3 OF THOSE HAVING SUBSEQUENTLY PURCHASED A HOME.
