The Board shall determine whether a conflict exists and is material, and in the presence of an existing material conflict, whether the contemplated transaction may be authorized as just, fair, and reasonable to Revive & Restore. The decision of the Board on these matters will rest in their sole discretion, and their concern must be the welfare of Revive & Restore and the advancement of its purpose.
